Commissioner Rick Elliott made the motion, duly seconded by Commissioner Kevin Hackler to approve and adopt the 2021-2022 Budget as presented.

MINUTE 012:2021

Commissioner Mark Ross made the motion, duly seconded by Commissioner Kevin Hackler that the property tax rate be decreased by adoption of a tax rate of .5650 which is effectively a 1.5% decrease in tax rate from previous year. This budget will raise less revenue from property taxes than last year's budget by an amount of -\$42,335.00 which is a -1.56% decrease from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$8,282.00.

MINUTE 015:2021


Commissioner Rick Elliott made the motion, duly seconded by Commissioner Kevin Hackler to approve the local order for a general election.

Motion carried unanimously.


